

## FUNDING INCLUDES TWO PROJECTS IN ANOKA COUNTY BILL CALLS FOR \$6.4 MILLION IN LEGACY AMENDMENT FUNDS TO 15 METRO AREA WILDLIFE AND CONSERVATION PROJECTS

Mar. 5 — Two freshmen, state Reps. Mike Freiberg (DFL-Golden Valley) and Anna Wills (R-Apple Valley) introduced the bill Monday, and say they have 33 bi-partisan co-sponsors from all seven metro counties.

They say their bill, HF 1119, won't take funding away from other state-wide wildlife, habitat and conservation projects, because there is \$10 million left unspent in the Outdoor Heritage account for next year.

Wills said in a statement: "These Legacy dollars have been set aside by the voters. The funds will be spent. It is only right that the needs and resources of the metro area are addressed. We are not seeking to take funds away from other projects."

The 15 projects, according to the bill as introduced, are:

- \$500,000 is for Dakota County to convert existing agricultural land and low-quality woods and grassland in Whitetail Woods Regional Park to prairie and oak savanna centered around an existing wetland, resulting in substantial habitat improvements for waterfowl and other wildlife.

- 60,000 is for Dakota County to protect and enhance Miesville Ravine Park Reserve through earth shaping, slope stabilization, and perhaps piping of one severe gully erosion situation and other eroding sites that are presently contributing sediment to Trout Brook, impairing water quality and the brook trout population.

- \$500,000 is for the City of St. Paul to remove 18,000 tons of contaminated materials and preserve sensitive access to natural amenities and nature-based recreation in Lilydale Regional Park. Funding would help to improve access to Pickerel Lake, while enhancing habitat and improving water quality.

- \$915,000 is for the Minneapolis Park and Recreation Board to protect, restore and enhance shorelines; reduce invasive upland species; and repair erosion and unpaved walking paths at Sweeney and Twin Lakes and to enhance the Wirth Lake wetland complex; reduce invasive upland species; correct erosion problems; close unauthorized trails; and repair unpaved walking paths in Theodore Wirth Regional Park.

- \$468,000 is for Ramsey County to restore 72 acres in Battle Creek Regional Park along the bluff of the Mississippi River, including restoration and enhancement of prairie, savanna, oak woods, and shrub swamp seeps to improve waterfowl and upland game bird feeding and nesting habitats.

- \$210,000 is for the Three Rivers Park District to restore the water quality and game fish habitat in Lake Independence in Barker Park Reserve by reducing phosphorus loading from Spurzem and Half Moon Lakes through treatment with aluminum sulfate.

- \$400,000 is for the Three Rivers Park District to enhance and restore the quality of Cleary Lake and restore the fishery by controlling curly-leaf pondweed, reducing phosphorus runoff from the watershed, and controlling internal phosphorus cycling with aluminum sulfate.

- \$200,000 is for Carver County to restore and enhance Lake Minnewashta Regional Park by converting 37 acres of existing turf or old fields to native prairie and oak savanna. These areas are identified in the park master plan as medium to high potential sites for restoration.

- \$270,000 is for Anoka County to restore and enhance 120 acres of prairie and woodland habitat within the 273-acre Mississippi West Regional Park. Outcomes will include increased habitat for game and nongame species and benefits to migratory waterfowl on the Mississippi flyway.

- \$200,000 is for Anoka County to restore 45 acres of prairie and oak savanna and remove invasive species from 40 acres of riparian forest land at Rum River Central Regional Park. The restoration will benefit the adjacent 550-acre Cedar Creek Conservation Area, which is open to hunting and was funded through a recent appropriation from the outdoor heritage fund.

- \$338,000 is for Scott County to restore and enhance 150 acres within the 1,150-acre conservation-focused Doyle-Kennefick Regional Park. The project site is part of an 850-acre mosaic of natural lands including Minnesota County Biological Survey forest and some of the highest quality wetlands in Scott County. The park master plan identifies this natural complex to be conserved for habitat and biological diversity with very light recreational development.

- \$37,000 is for Scott County to restore and enhance Cedar Lake Farm Regional Park by partnering with the Cedar Lake Improvement District and Scott Watershed Management Organization for four years of treatment to control the curly-leaf pondweed infestation dominating Cedar Lake. The goal is to restore 700 acres of shallow lake, improve fishing opportunities, and increase native aquatic plant habitat.

- \$1,523,000 is for Scott County to restore and enhance 302 acres of contiguous forest, wetlands, and lakeshore in Spring Lake Regional Park by improving habitat for interior forest birds, waterfowl, and amphibians. Adjacent to Upper Prior, Spring, and Artic Lakes, this site is part of a larger permanent habitat network.

- \$425,000 is for Washington County to restore and enhance Lake Elmo Park Reserve by creating 168 acres of interconnected tallgrass prairie through the restoration of 12 wetland basins that are scattered throughout an existing tallgrass prairie complex. These diverse landscapes provide critical habitat for native ground-nesting birds.

- \$350,000 is for Washington County to restore and enhance rare and unique forest communities identified by the Department of Natural Resources in Lake Elmo Park Reserve and St. Croix Bluffs Regional Park. These forests provide exceptional habitat for native and migrating bird species and represent some of the best opportunities for avian habitat improvement in Washington County.

## Three finalists named for Minnesota Supreme Court vacancy

Mar. 12 — Three well-known legal minds are finalists for a seat on the Minnesota Supreme Court, to replace Justice Paul Anderson who will retire in May.

The Commission on Judicial Selection has recommended former U.S. Attorney David Lillehaug and two sitting Minnesota Court of Appeals judges — Edward Cleary and Natalie Hudson — as finalists.

Gov. Mark Dayton will interview them and choose one to fill the seat.

Bios of the three, from the governor's office, say:

- Cleary currently sits on the Minnesota Court of Appeals as judge for the Fourth Congressional District. He previously served as judge and Assistant Chief Judge for the Second Judicial District. From 1997-2002, Judge Cleary served as the Director of the Office of Lawyers Professional Responsibility, and prior to that, practiced law for 20 years, concentrating on criminal defense and civil litigation. He is a past president of the Ramsey County Bar Association and served on the Minnesota State Bar Association Governing Council. In addition, Judge Cleary served as an adjunct professor at the University of Minnesota Law School from 2000-2012.

- Hudson currently sits on the Minnesota Court of Appeals as an at-large judge. Prior to her appointment to the Minnesota Court of Appeals, she served as an Assistant Attorney General for the State of Minnesota in the Criminal Appeals and Health Licensing Divisions. Judge Hudson has also served as the City Attorney for the City of St. Paul, and was the Assistant Dean of Student Affairs at the Hamline University School of Law. She is a member of the American Bar Association's Judicial Division and is a member of the Minnesota Women Lawyers Advisory Board.

- Lillehaug is an officer and shareholder with Fredrikson & Byron, P.A., and is active in pro bono work. His 30-year litigation practice focuses on public law and complex cases — civil, criminal, and administrative — with a particular emphasis on state and federal constitutional issues. As U.S. Attorney for the District of Minnesota, he was the federal government's chief prosecutor and civil lawyer in the state and worked closely with all federal investigative agencies. He serves on three non-profit boards and on the Minnesota State Bar Association's Mock Trial Program Advisory Committee.

## Candidates for State Republican Party Chair will face off in March 21 forum

The election of the new chair of the Republican Party of Minnesota has taken on some aspects of a broader campaign, one designed to communicate to voters and not just party activists.

The latest indication is a candidate forum sponsored by Republicans in the second congressional district. The district's chair, Bill Jungbauer, said he expects all four candidates for the seat -- Keith Downey, Bill Paulsen, Don Allen and Bonn Clayton -- to participate in the forum moderated by activists Walter Hudson and Chris Andryski March 21 at 7 p.m. at the Eagan Community Center.

To amp up the participation, the forum features a Facebook page, social hour and cash bar. Downey and Paulsen are running aggressive campaigns to reach out to the 250 delegates who will meet April 6 to make their choice.

The new chair has a giant task, ahead including retiring \$1.6 million in debt, creating new structures to help candidates in 2014 and, most importantly, telling Minnesota voters why they should return Republicans to a majority status by winning the governor's office, the Minnesota House and U.S. Senate and Congressional seats.

The forum will be more than an inside-politics event. "I would hope that delegates, activists, and voters see that we are vetting our officers and that we have a great field of candidates," Jungbauer said.

Meanwhile the man who many believe had the most thankless job in the state will have a proper sendoff.

Pat Shortridge, chair of the Republican Party of Minnesota, leaves the position April 6. On Monday, March 18, conservative blogger and activist John Gilmore will host a thank-you event at the Seven Sushi and Steak Ultralounge in Minneapolis.

"He stopped the bleeding and he made us believe that we would live to fight another day if we stopped fighting among ourselves," Gilmore said in explaining why he decided to organize the party.

Shortridge, who took no salary, replaced Tony Sutton. Under Sutton's management, the party accumulated a \$2 million dollar debt and fines from the Campaign Finance and Public Disclosure Board. Shortridge is credited for reducing the debt by about \$300,000.

Gilmore is rounding up Republican notables to headline the evening. A Facebook event page extends the invitation to all politicians.

The Health Insurance Exchange passed the Senate Floor on Thursday. We offered common-sense amendments to try to improve this bill, but they were rejected.

Minnesota already has the best health care system in the nation. This bill proposes to spend untold millions of dollars, but will do nothing to improve quality, access or cost of care. Instead, it will simply increase costs for all Minnesotans, limit your health care choices, and destroy innovation, all while leaving many uninsured.

My preference would be to increase competition by allowing out-of-state companies to sell their products here, and introduce a voucher program rather than force people into plans they may not need. These are consumer-oriented solutions that can actually help Minnesotans and lower costs.

The Senate Education committee this week passed a bill by Sen. Dibble that would aim to address bullying in schools. I admire the intent behind the bill, and we can all agree that we want to create a safe, respectful learning environment for our children. My concern is that this legislation will have no impact. Instead, it will cost millions of dollars, add layers administrative paperwork, and increase burdens on teachers. We should be careful as we approach this issue, and focus on enforcing the bullying laws we have in place first and foremost.

I have authored Senate File 611, which would address bullying in a different way. It would ensure that schools are utilizing Minnesota School Board Policies 514 and 524, which are already in place to tackle the bullying issue.

Senate File 497, The White Bear Lake water level bill that I and others have been working on for months, cleared its first hearing on Wednesday. It was heard in the Senate Environment budget division, and laid over for inclusion in the Legacy bill. This bipartisan bill had no opposition in committee, and I am pleased that it is working its way through the process.

On Monday, Senate File 806, which would allow Lino Lakes to regain legal possession of tax-forfeited lands, was heard in the Environment and Energy committee on Monday. It was laid over for possible inclusion in their omnibus bill. Doing so would improve the city's ability to put these lands to productive use.

You may have heard recently about a proposal that would add a surcharge on to your health insurance, homeowners insurance, and car insurance to fund public pensions. Rest assured that I will not support this bill. It is not a solution to the problems that our pension system is facing.

Yet another proposal in the House would raise taxes and fees on beer and wine at wholesale, and another would raise the gas tax and various other transportation taxes. I do not support these regressive taxes. I have not yet seen any specific legislation on these issues, and I will review everything carefully. This extra revenue is unnecessary.

### ANOKA CONSERVATION DISTRICT TAKING TREE AND SHRUB ORDERS UNTIL APRIL 12

Warm weather is just around the corner and it is a great time to start planning your Spring planting projects. There are many purposes and uses for trees. Several rows of strategically placed trees and shrubs can make an excellent snow fence, planted on the west and north sides of your house, they can reduce your heating bill by up to 20%. A windbreak planted along your property boundary provides privacy and wind protection unlike any manufactured fence. All plantings will provide food and shelter for wildlife in addition to providing aesthetics and landscape structures. Optimum spacing is 6' between shrubs, 15-20' between trees and 15-20' between rows. There should be 3-7 rows with deciduous shrubs to north and west, then deciduous trees and finally evergreen trees to south and east.

An inexpensive way to purchase your trees and shrubs is through the Anoka Conservation District (ACD). The ACD offers 25+ varieties of economically priced seedlings and transplants sold in bundles of 10 and 25 for just a little over \$1 per tree and are now taking pre-orders until April 12th, or until sold out with any remaining stock sold at the tree and shrub pick up on April 27th at the Anoka County Fairgrounds between 8am-10am. You do not need to be an Anoka County Resident to order! To assist you in making your selection, the [AnokaSWCD.org](http://AnokaSWCD.org) website features each species with detailed descriptions and images of each of the varieties being offered. The website also contains information about the kinds of trees and shrubs to plant in your particular situation along with planting directions. ### Proposed Sales Taxes on Businesses May Be Rolled Back

Nearly two weeks ago, the office of Management and Budget released the February Forecast. The forecast contained good news for Minnesota and for Minnesota's schools.

In response to the improved economic outlook, as well as to an outpouring of opposition against his initial proposal, the governor announced that he would revise his proposed budget for the 2013/2014 biennium. Governor Dayton's original budget proposal included, among other new taxes, expanding Minnesota's sales tax to items such as haircuts, business to business taxes, and clothing over \$100. As of Wednesday, March 13, Governor Dayton has not released his new budget. Although the details of the proposal have not been released, it is heartening to hear that the business community has convinced Governor Dayton that taxes do have consequences for Minnesota's jobs and economy.

State spending should be done in a way that promotes effective government that builds a healthy economy and promotes business and, consequently, jobs. As it currently stands, Governor Dayton would be raising \$3 billion in new taxes to address a projected deficit of \$627 million. Hopefully the governor keeps this in mind later this week and releases a budget that promotes more efficient, not more expensive government.

### LET'S TAX THE POOR

One thing that President Obama and Governor Mark Dayton have in common is their constant refrain of "tax the rich." Every time there is discussion about budget deficits their call is for higher taxes on the rich. If there is a call to reduce government spending their immediate response is "we need a balanced approach," shorthand for we need more tax revenue. So let's have a balanced approach, a truly balanced approach to income taxes; let's increase taxes on the poor, so everyone pays the same tax rate. Let's get rid of the "Earned Income Tax Credit," the tax program which actually gives low income people money and instead impose one simple tax rate for everyone. After all when we go to the grocery store we all pay the same for a gallon of milk or a loaf of bread. When we go to the gas station we all pay the same for a gallon of gas. If you buy a car or a television the price isn't based on what you earn, the price is the same for everyone.

Why, if we are consuming governmental services should it be any different? We all benefit from a strong national defense, good public schools, and a well maintained transportation system. Why shouldn't everyone pay a portion of the cost? Why should the cost of government services be any different for the person who earns \$10,000 from the person who earns ten million dollars? Does the person who makes ten million dollars receive more government services than the person who earns \$10,000? The likelihood is the person who earns \$10,000 per year consumes more government services than the individual who makes ten million. At a minimum, a singular tax rate imposed on the rich and the poor would obviously still result in a rich person paying more in taxes.

But the mantra of the "rich don't pay their fair share" is

the code for more income redistribution. The progressives' proposed solution for every budget shortfall is "tax the rich." In the U.S. for over one hundred years, the system of taxing the rich to pay for government has been promoted as the solution. But a look at the facts shows it doesn't work. One hundred years ago this month, in 1913, the states ratified the 16th amendment to the constitution which allowed the federal government to levy an income tax. Years earlier the Congress had passed an income tax but the Supreme Court struck it down as unconstitutional. In 1909 Congress passes a constitutional amendment and by 1913 three-fourths of the states had voted to ratify the 16th amendment.

Within eight months of adoption of the amendment Congress passed the first income tax code which featured a graduated tax schedule starting at 1% with seven tax brackets and a top rate of 7%. If tax brackets were adjusted for inflation the bottom rate of 1% would apply to incomes of less than \$460,000. In other words, only the very rich would have to pay more than 1% in Federal income tax. But, of course, there were numerous exemptions and deductions which meant that only 1% of the population paid one percent of their net income. Within three short years Congress raised the lowest tax rate from 1% to 2% and increased the top rate to 15%.

By 1918 another tax rate increase was passed raising the bottom rate to 6% and the top rate to 77%. But even with these dramatically increased rates only 5%

of the population paid income taxes. During the booming economy of the 1920's Congress repeatedly cut tax rates ultimately returning to a bottom rate of 1% and a top rate of 25%. With the onset of the Great Depression, Congress soon returned to their tax and spend ways and raised tax rates to a low of 4% and a top rate of 79%. Later the top rate was raised to 90% and President Franklin Roosevelt even issued an Executive Order taxing all net income above \$25,000 at a rate of 100%.

Another important income tax regulation that changed in the 1940's was the implementation of tax withholding by employers. This greatly eased tax collection and substantially reduced the awareness of how much tax was being collected which made it easier to raise taxes in the future.

Now fast forward to our current economic dilemma. Just weeks ago, Congress in response to out of control budget deficits and pressure from President Obama raised the income tax rate on the top 2% of earners; despite the fact that 49% of Americans pay zero federal income tax. Congress believes it's okay to increase taxes on those who already pay 40% of total federal income taxes.

So let's reverse the income tax policies of the last one hundred years and start taxing the poor. Instead of giving money to low income workers, let's tax their wages. A simple flat tax rate of 10% should work. The individual who earns \$10,000 would pay \$1,000 in federal income tax and persons earning one million dollars would pay \$100,000, no exemptions and no deductions.

The liberals would pity the poor and therefore not want to increase taxes and the rich would pay their fair share. Everyone would contribute something to support needed government services for the benefit of society.

**WATCHDOG EDITORIAL:  
EVERYONE IS RICH**

Everyone is rich, according to Governor Dayton and the DFL majorities in the Minnesota legislature.

The Party of the Workin' Man, that always pledges to be interested strictly in confiscating from the rich, just can't keep their hands out of every man's wallet.

When it comes right down to it, the DFL always, always, picks the government budget over the family budget.

So how has our DFL majority treated the Workin' Man so far? No regressive taxes, right?

Wrong.

Alcohol and tobacco taxes are the most regressive, hammering the poor.

Governor Dayton proposes a \$150 million tobacco tax increase. If the governor's proposal wasn't enough, the legislature has weighed in with a tobacco tax increase of its own: House File 91 and its Senate companion number 209.

This bill would increase the tax on tobacco products,

including cigarettes and snuff, by increasing taxes on distributors, retailers, and consumers. This gem would increase tobacco taxes by \$441 million over the two-year budget cycle.

In other words, this increase is nearly three times as big as the Dayton increase.

And don't forget about that other sin, booze.

While Governor Dayton left that tax stone turned over, the DFL legislature didn't.

Rep. Karen Clark has proposed a bill to nearly quadruple the tax on beer while also jacking up taxes on wine and hard liquor.

That Joe Six Pack. It's about that rich SOB paying his fair share.

Another extremely regressive tax is the gasoline tax and associated taxes and fees revolving around cars, that fossil fuel burning menace that keeps you from riding the trolley and other more eco-friendly modes of mass transit.

The DFL legislature has a plan for that, wanting to raise the gas tax by 9.5 cents per gallon, as well as raising tab fees and expanding the sales tax for transportation items by another half cent.

And we're not done. The Department of Revenue had this to say about two other aspects of his tax plan:

State Sales Tax. In combination, the rate cut (down 20%) and expanded tax base yield a tax increase of nearly \$1.5 billion per year. The net impact of the sales tax changes are regressive, as expected.

Local Sales Taxes. Base expansion will increase local sales tax revenue, as will the proposed 0.25% transit tax in the 7-county metro area — an increase of roughly \$300 million. All of this leads to a vicious DFL-inspired taxing circle.

They raise regressive taxes and then turn around and complain that the system overall is too regressive — it points to rank hypocrisy, claiming to be all about the working man while taxing the tar out of him to feed an ever growing, ever more aggressive constituency of takers, voracious consumers of government services and treasure. Regressive taxes? The DFL is starting to corner the market.

**THE POLITICS OF ENVY**

Was it really news this week when the Star Tribune reported that a poll they commissioned revealed that the only taxes Minnesotans are interested in raising are those on someone else?

We think the real news there was that only 54% are okay with raising income taxes on the “rich.”

Having said that, it was the only tax that got majority approval in the poll.

While the public policy and fiscal implications of tax increases are extremely important, it is just as important to explore the moral and emotional aspects of these policies.

Frankly put, the politics of class warfare is on full display with Governor Dayton's income tax proposal.

He foments and whips up a terribly ugly human emotion — envy. He demands that successful people turn over more of their resources to government, in large part because they deserve it.

Far from being celebrated as job creators and the epitome of the American Dream, successful people are held up as objects of derision and ridicule. Moreover, they are used as wedge issues and the subject of a harsh political narrative.

Look at the rich! They have more than you do! Make them pay more. And watch those Republicans defend them!

It's so very European, where the entrepreneur is reviled and as popular the local street criminal.

It seems the Left is more interested in making excuses for not succeeding while punishing those who do.

**HERO OF THE WEEK**

Let's hear it for state Senator Dave Brown (R-Becker). Senator Brown offered an amendment to the disastrous health insurance exchange that was debated and passed last week in the Minnesota Senate.

Brown's amendment would force every legislator to buy health insurance from the very exchange they created.

His amendment was adopted but the victory will be short lived.

It will likely be removed in conference committee.

Nonetheless, Sen. Brown is to be commended for this effort and his other actions to promote freedom and limited government.
