

## No voter support? No problem! Minnesota school boards can raise taxes

ST. PAUL, Minn. — Minnesotans faced 39 school operating levy referendums on the ballot this fall, fewer than in any election since 1996, nixing one of every four proposals at the polls.

Chalk one up for taxpayers? Not exactly. Many school boards had already unilaterally raised school levies on their own long before Election Day, without seeking voter approval.

The 2013 Minnesota Legislature gave school boards the authority to effectively go behind the backs of local taxpayers that decline to raise their school taxes.

“The argument is the school board is locally elected and if the citizens don’t like what the school board does, they can vote them out of office and reverse the referendum decision that they made,” said Tom Melcher, director of school finance at the Minnesota Department of Education. “But I haven’t heard a lot of pushback.”

Educators still call it a “referendum,” but school board members now cast the only votes in deciding whether to impose an up to \$300-per-pupil operating levy for five years without public approval.

“Given that the word is referendum, you’d think that yes, the levy authority is there because the voters approved it. But they didn’t, so we kind of have an oxymoron going here,” said Bob Porter, Minnesota Department of Education school finance specialist.

As school boards lined up to capitalize on their newfound power, the number of operating levy-free districts quickly plunged from 39 to nine. Only a handful of small, rural district boards resisted the temptation to up the ante on taxpayers with increased state aid as part of the equation: Cass Lake, Floodwood, Kelliher, Lanesboro, Littlefork-Big Falls, Prinsburg, South Koochiching, Underwood and Verndale.

“What the governor and the Legislature have done is taken away decision-making authority that used to be in the hands of voters, instead giving it to school boards, allowing them to raise taxes or impose taxes unilaterally,” said Jonathan Blake, a Freedom Foundation of Minnesota analyst.

Altogether, 123 school boards have taken advantage of the \$300 provision to initiate, increase or convert their levy levels, Minnesota Department of Education figures show. Schools defend the process as a way to equalize educational opportunities for districts with a smaller property tax base, mainly outside the Twin Cities metro area.

“It was basically done to solve an equity problem because there are districts with nothing or very small amount of a levy next to a district with a \$2,000 per pupil levy,” said Greg Abbott, communications director for the Minnesota School Boards Association. “So it was an effort to try and make things more equitable from district to district.”

Rush City schools tiptoed around taxpayers’ concerns before voting to max out at a summer board meeting.

## Don’t let Craigslist Losers Ruin the Holiday Season

A recent study showed that 97% of Anoka County residents have access to high speed internet. Access is defined broadly to include home, work, cell phone, or a nearby location like a neighborhood coffee shop. As a result, most of us have easy access to online shopping like eBay, Sears, Target, etc.

All of these options have things in common such as money back or satisfaction guarantees, ease of use, and quick shipping to your front door. Your transaction from start to finish typically does not require you to speak with another human being. In the case of UPS, they typically drop off the package at the door, ring the bell, and walk away before you even have a chance to answer.

Another online option is Craigslist. But is it a good option for holiday buying and selling? Is it better to find products online, but then complete the transaction in person and exchange payment at that time? Is Craigslist a good place to sell items you no longer need in order to generate some additional spending money for the holidays? Here is some food for thought.

For those unfamiliar with the history of Craigslist.org, it was originally started by Craig Newmark in 1995 as a way to freely share information in San Francisco. From there it has grown to a website that is now used in 70 countries, including hundreds of cities across the world. According to Craigslist, every month 60 million people in the US use it to post over 80 million classified ads. Most ads can be posted for free.

I have used Craigslist for over 10 years. These

“Board members discussed the need to be sensitive to citizen tax obligations, while providing for district needs related to adequately staffing buildings, maintaining district facilities, and staying current with curriculum and technology...this additional \$300 per student levy will cost about \$59 per year for \$100,000 property value,” according to published school board minutes of a July 17 meeting.

Many property owners in districts statewide will also be assessed for a \$424-per-pupil “local optional revenue” operating levy approved by legislators, rather than voters. Technically, school boards can opt out of the levy, but in practice seldom do.

“The only way a district is going to generate less than the \$724 is if the school board decides not to use all the levy authority that the Legislature has provided it,” said Porter, the state education finance expert. “Why would they not do that? The two basic reasons would be they think they can operate effectively without that revenue or they figure they’ll never be re-elected, if they approve of it.”

Where does that leave residents of North Branch, an east central community where voters turned down eight straight school levy proposals? Taxpayers will be assessed based on an operating levy referendum of \$724 per pupil next school year, once finalized by the school board next month. To offset part of the cost, legislators upped the percentage of state aid, which depends on a district’s property values.

With part of the board-approved increase already in place, North Branch has added 20 staff and resumed a Monday through Friday school week, after several years on a cost-cutting four-day schedule.

“Some people don’t like the fix, but it is what it is. And we have been asking for a change in funding for a long time,” said Deb Henton, superintendent of North Branch schools. “This is what the Legislature gave the opportunity for school boards to do, and our members have voted in favor of it and felt they had advocated long enough.”

The trade-off between less taxpayer control and more school board authority concerns at least one North Branch school board member.

“The majority of the people that voted me in there would not pass a levy because we’ve got a city that’s \$62 million in debt,” said board member Randy Westby. “The real estate market is declining even now, when things are starting to pick up overall, because we’re too reliant upon property taxes.”

last few years, what has attracted me to Craigslist was the desire to sell low value toys, books, and other items the kids had outgrown. I figured why not make a few dollars, sell locally, and avoid fees that online auction sites charge. It seemed like a simple concept. You post an ad, people reply, you arrange a meeting time and place, and make a transaction. I want money and they want the product. Items get reused and stay out of the waste stream.

Within about two or three transactions, I encountered my first problem buyer. When I looked online to see if this was a common occurrence with other sellers, I discovered that there was a term attached to these people. Problem buyers or sellers were referred to as “Craigslist Losers”. There are various websites dedicated to stories about these people. If you get a chance to read some of the entries, you should. They are hilarious and give some real world insight into the state of society these days.

One of my many encounters with Craigslist Losers was a person who wanted to buy a used Little Tikes kitchen. I posted five photos, clearly stated it was used outdoors, and priced it to move at \$15. It originally sold for over \$100. After changing my schedule to fit one potential buyer, she shows up 90 minutes late, no apology, complains about it having been used outside, and then leaves. Another Craigslist Loser was 30 minutes late for the time she set, so I called her. She replied, “I changed my mind, that’s why I didn’t show.” The list of crazy, rude, and obnoxious buyers goes on and on.

You would probably expect that if I was giving something away for free, nothing could go wrong, right? Think again. I had a Craigslist Loser complain about free firewood that I placed on my boulevard. The complaint you ask? Well apparently it wasn’t the type of wood he was looking to burn. Apparently in addition to a close up photo of the wood, I was supposed to identify the quantity and species of every piece. Sorry, but I don’t have a Forestry degree.

Even though I had mixed experiences dealing with buyers on Craigslist, I thought that sellers may be different. After all, they have a product they want to sell, and they want to get paid cash. Generally cash is a good motivator for the person who is on the receiving end of the greenbacks, right? Think again.

My kids have been interested in LEGOs for a number of years. I was a big LEGO user when I was a kid too. As time went on, their interest has increased. They always wanted to go over to the grandparents’ house because they still had my LEGO sets from the 1980’s. So we decided to do something bold. We decided to get rid of practically every toy in the house and focus 100% on LEGOs. After seeing a number of videos from LEGO conventions around the world, they also decided that they wanted to start building large projects.

A year ago, I started posting ads on Craigslist advertising that I paid cash for LEGOs. Specifically I offered to pay for blocks by the pound. Gather up your boxes of blocks, and I will stop by your place, weigh them up and pay you on the spot. It seemed like a pretty easy proposition.

For over a year, I have met dozens of people around the Twin Cities to purchase their used LEGOs. Some were parents who wanted to clean out the house. Others were college students who needed some spending money. When people want to get paid, most are timely and act professional, with the key word being “most”. Even when paying cash, I still encountered a number of Craigslist Losers.

One Craigslist Loser from Woodbury, Tony, set a time to meet near his house by the Home Depot. I rearranged my schedule to fit his. Shortly before Tony and I were supposed to meet, he contacts me to cancel. I respect that sometimes emergencies come up, so we rescheduled for the next day.

The next day, being a little concerned about Tony’s reliability, I contact him to confirm our meeting. No response. This was highly unusual because I could gather that Tony was in his late 20’s and was the type of person who has his cell phone glued to his body day and night. So I email him again, and again, and again. Finally several hours after our meeting time had passed, he sends me a nasty message telling me to stop inquiring about the meeting we were supposed to have had earlier in the day. Keep in mind that this was a meeting where if I would have shown up at the time and place he proposed, he would have never shown.

Tony and I had a few email exchanges after this and it became clear that he simply didn’t respect anyone

## OBAMA'S POLITICAL DEATH KNELL

Of course, much has been written in the aftermath of the recent election regarding Barack Obama and the remaining two years of his failed presidency.

## SERIOUS QUESTIONS FOR SEN. ORTMAN

We understand that many of our readers long ago nixed the Star Tribune - and for good reason.

But this week, that publication via contributing columnist Michael Brodkorb, uncovered shocking and very serious allegations against state Senator Julianne Ortman and her campaign manager that, if true, comprise a serious breach of legal and ethical

boundaries.

The first allegation concerns Ortman's campaign manager, Andy Parrish. Two GOP candidates who were competing against Ortman for the GOP endorsement for U.S. Senate say that Parrish approached them at the state convention, offering to retire campaign debt in exchange for an endorsement of Ortman's candidacy.

In fact, one candidate, Monti Moreno, alleges that Parrish indeed wrote him a check in a partial (parsimonious?) pay off of that quid pro quo.

Expect multiple investigations to resolve this issue to determine exactly what happened and what Sen. Ortman knew and when she knew it.

This is just the latest in a string of legal and other controversies that seem to follow Mr. Parrish like stink on manure. Like this issue and this issue. And this issue.

Moreover, what does that say about Ortman's judgment that she would hire a guy with obvious judgment and self-control issues.

The second issue reported by Brodkorb is the serious problem the Ortman campaign is experiencing in properly filing campaign finance reports.

As reported, the Ortman campaign has had long-running problems in filing both timely and accurate reports.

In fact, a recent submission to the federal elections authorities contained amendments to every previously filed campaign report.

Even more troubling, the latest amendments all correct previous understatements of campaign spending that understated spending by tens of thousands of dollars in some cases.

The effect of the underreporting was to show a healthier state of finances than was the actual case.

This situation begs a very important and fundamental question: Was Ortman's campaign that incompetent or did the candidate intentionally overstate the financial health of her campaign in order to mislead delegates and the public into believing it was stronger than it really was?

After all, financial strength is an important indicator of candidate viability, especially in an endorsement contest, where other indicators like polling are often lacking.

Only the candidate herself knows the answer.

The state GOP better get after this issue and demand a firm resolution. There has been way too much controversy and drama in the family of late.

Whether it's an endorsed candidate's legal antics over a DUI or a party leader calling for an entire class of people to be "fragged," we've had enough of this garbage distracting from a party that is doing good work to rebuild the brand and dig out of a serious financial hole.

The last thing our new House majority needs is a legislator sitting under a legal and ethical cloud that distracts from the upcoming mission of governing the Minnesota House against the DFL Senate and a DFL governor.

## MEANWHILE IN THE SAINT PAUL PUBLIC SCHOOLS

Unless you were living under a rock this week, you saw Saint Paul School Superintendent Valeria Silva issue an ignorant and thoughtless Tweet regarding the Ferguson situation:

**BEWARE THE TRAIN**

This week provided yet another embarrassing news story regarding Northstar rail and its abject failure to deliver upon the promise of high ridership, traffic congestion relief, and economic development.

This isn't because gas is cheap. Or because oil trains are eating track capacity. Or because the weather is bad. Or because the train doesn't run to Saint Cloud (which, by the way was a decision of the federal government, not Tim Pawlenty).

It's because Northstar commuter rail was sold on a foundation of misrepresentations, half-truths, and bogus promises.

The epic fail that is Northstar is a cautionary tale for both the new House GOP majority in Saint Paul as well as communities that would "benefit" from light or commuter rail (we're looking at you, Eden Prairie).

Recall the history here in Anoka County.

When all the promises were made, right thinking taxpayers asked why a commuter train was deemed a better option than an expansion of Highway 10.

else's time but his own. He lacked complete sense as to what it means to conduct a respectful business transaction. Generally the Craigslist Losers I have encountered all have these traits in common.

Another Craigslist Loser from the St. Cloud area set up a meeting at Arbor Lakes in Maple Grove. I never actually got their name because we simply had a cell phone text conversation that went quite well. All I have to identify them was their cell number of (320) 979-9708. Yes, they were a no show. I texted and called, leaving a voicemail message stating that it was no problem if there was an emergency or they were simply late. I had three hours' worth of shopping to do in the area. After I finished my shopping, I called back and it was evident that they now had turned their phone off. I never heard from them again.

Over the summer, I met another Craigslist Loser from Coon Rapids. She believed that I was not only buying LEGOs, but also the crappy beat up bins that they were stored in. I respectfully informed her that I can't justify paying \$3 a pound for bins, or roughly \$10 each, which is why I bring my own bins. When you buy bulk items at the grocery store, you only pay for the fruit or vegetable. The weight of the bag, which is generally negligible, is always deducted.

After informing her of this, she then tells me that other people are interested in buying them. I asked her if they knew they would be forced to buy the bins also. She had no answer. I made her an offer minus the price of the bins. She turned me down. As I started walking out, she then accepted.

The most recent situation involved a seller in Washington state. We struck a deal for LEGO railroad tracks and other railroad items that the kids wanted for Christmas. The price we agreed to was very reasonable. When the package arrived, it concerned me that the items were not in a cardboard box with packaging material. Instead, they were jammed into a hard plastic box and wrapped with craft paper. Not surprisingly, an important tab had broken off one of the items. Upon further inspection, it became evident that it did not break off during shipping. If it had, the broken tab would have been in the box. Plus further examination showed stress marks where two pieces were disassembled prior to shipping.

I contacted the seller to let him know the package arrived, but that the switch track was broke. I wasn't sure what reply I would get in light of the situation. He replied that he has received broken items in the mail before and that is just the way it goes, and that the item sort of works even if it is broken. Because of situations like this, I generally do not deal with out of state sellers unless the price is very reasonable. So this essentially downgraded a great deal to just a good deal.

As you can imagine, these are just a few of the stories that come to mind when people ask me about my experience with Craigslist. So taking all of this into consideration, is Craigslist a good option for holiday buying or selling? In my opinion I would say no. I believe most people want holiday buying and selling to be as low stress as possible because the holiday season is generally stressful enough already.

If you do decide to use Craigslist this holiday season, I offer the following advice. First, be prepared to have very low expectations of the people you will meet, and anticipate that approximately one out of six people will be Craigslist Losers. When buying, have two or three options available and when you encounter a Craigslist Loser, immediately go to the next option. When selling, do not rearrange your schedule no matter how tempting it might be to make a sale. Don't put yourself in a position where you are waiting for a buyer who will never show up.

Finally, one way to weed out many Craigslist Losers is to insist upon getting a phone number and actually making voice contact with the buyer or seller. Don't be surprised that when you ask for a telephone number and insist on a phone conversation, some will simply stop communicating with you. Also only use Craigslist when you have plenty of time to burn. What could take a few clicks on a department store website could take up to a week on Craigslist.

**Greater Minnesota legislative wish-list includes broadband and job training**

The new Republican majority in the Minnesota House of Representatives is interested in greater Minnesota issues, so many hope to see more emphasis at the state Capitol on such things as broadband and job creation.

Republicans gained 11 seats in the House to take control; 10 of those were from outside the metro area.

The question is: will that translate into more state funding for high-speed broadband, job training programs, workforce housing and transportation upgrades?

Gary Evans, president of the Greater Minnesota Partnership, told the *Rochester Post Bulletin*: "Greater Minnesota is where the [political] shift occurred, and I also think that that shift is somewhat directly proportional to a dissatisfaction in Greater Minnesota relative to the amount of money spent outside the metro area as opposed to inside it."

Evans' group, made up of state-wide businesses, chambers of commerce, cities and nonprofits wants the Legislature to expand high-speed broadband access, to the tune of \$200 million.

Employer-driven job training is also on the list, as is workforce housing and more money for roads and bridges around the state.

Among the transportation pushes will be more funding for upgrades to Hwy. 14 in southern Minnesota, Amanda Duerr, spokeswoman for the U.S. 14 Highway Partnership, told the paper. Voters expect such improvements from legislators, she said.

"I think there is going to be a lot of pressure and expectance from their constituents that they are going to deliver and that there is going to be an investment in transportation," she said. — *Joe Kimball, MinnPost*
